In accordance with the plan of basic organizational actions of the Federal Service for Supervision of Consumer Rights Protection and Human Welfare for the year 2015 VI All-Russian Scientific Conference with International Participation "Actual Issues on Safety and Public Health Risk Analysis under the Influence of Environmental Factors" will be held in Perm on 13-15 May 2015.

For the first time as the venue of the conference the famous Ural Resort "Ust-Kachka" (AMAKS Hotels & Resorts network) is selected, which is located in a pine forest on the embankment of the Kama River.

- 7. Development of medical prevention of noncommunicable diseases. Predictive medicine (molecular medicine) as a modern strategy for the effective prevention of nonspecific somatic diseases associated with environmental factors;
- 8. Children and adolescents health risk reduction in the community, in educational institutions, recreation and health organizations;
- 9. Modern aspects of occupational medicine. Workers' occupational health risk assessment.

- contest "Young scientist's best work";

- lectures by leading Russian hygienists, epidemiologists, and public health organizers of state sanitary and epidemiological service on topical issues of safety and public health risk assessment under the influence of environmental factors.

 - 2 line: empty;
 - 3 line: N. (Name) P. (Patronymic) Surname of the author Arial font, italic, 12 pt, centered;
 - 4 line: empty;
 - 5 line: Full name of the organization Arial font, italic, 12 pt, right alignment;
 - 6 line: City, country Arial font, italic, 12 pt, right alignment;
 - 7, 8 line: empty, further text of the presentation.

After references insert a brief summary to the article, not exceeding 100 words. Write down keywords.
